

Advocate. Sachin Sane sir delivered a lecture on the topic "Anti Ragging. started speech with an explanation to Anti-ragging". He told new definition for ragging is Any act of physical or mental abuse targeted at another student on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background. He apprised the gathering about the consequences of ragging which in her opinion would be devastating for both the parties. He said that even the honorable Supreme Court in its order has banned ragging in any form in institutions and many educational authorities like UGC, and the Government has issued stern warning against ragging and proposed ways and means to curb the menace of ragging. He discussed different measures for curbing ragging. Also, he explained legal provisions banning the provisions of ragging in India. In the session she highlighted all the landmark cases pertaining to ragging delivered by judisuries at large. he emphatically reiterated the reasons for why ragging should not at all be tolerated at any cost. he hoped that the institution had planned well to prohibit, prevent and eliminate incident of ragging in the campus. 


